## CHEWABLE C-300

- 300 milligrams of Vitamin C with bioflavonoids to increase effectiveness of Vitamin C in a great tasting cherry or orange-pineapple flavored chewable tablet.
- Vitamin C supports immune system function and collagen health.\* The primary function of Vitamin C is maintaining collagen.\* Vitamin C also helps form red blood cells, provides antioxidant protection against free radicals and supports the immune system.\*
- Vitamin C is a water-soluble antioxidant that neutralizes free radicals to prevent damage.\* It supports collagen production to benefit skin, teeth and bone health.\*
- Factors such as coffee, tea, smoking, illness, strenuous exercise and physical and mental stress all deplete Vitamin C levels in the body.\* The following drugs also tend to deplete Vitamin C in the system: Aspirin, Betapar, Brevicon, Cortisone, Demulen, Enovid, Indocin, Norinyl, Orasone, Prednisone and Sterazolidin.\*
- Chewable C-300 contains Bioflavonoids, which increase the effectiveness of Vitamin C by 50%.\* Pectin has been shown to be beneficial in managing cholesterol levels within normal ranges.\* Rose Hips are a great source of Vitamin C, but also contains pectin, citric acid and malic acid.
